June 27, 2012 Meeting Minutes

On June 27, 2012 Fusion FC Soccer Club conducted its monthly meeting for June. In attendance were Chris Pushart, Tim Foley, Mark Chesek, Bill Simmons, Josh Plaza, Dave Schlegel, Matt Neff, Angie Neff, Jared Miller, Jess Derrickson, Mike Dorwart, Dan Sorge, and Nevin Shenck.

President: Chris nominates Jess for vacant position board approves unanimously.

Secretary: Josh presents May 2012 meeting minutes. Chris motions to accept May 2012 minutes, Bill seconds and all in favor. Josh mentions June CPYSL meeting.

Registrar: 377 register players 265 travel 112 rec. All teams placed in CPYSL data base. Greg Alt's team was told EPYSA about 14 primary players. Larry needs all info from travel coaches by July 9th.

Office Manager: Angie reports Fusion does not have to attend York USA meeting at this time. Uniforms have been order for falls periods. 110 players have unpaid registrations at this time. 3v3 tournament has 33 teams right now. There is a lack of sponsors for 3v3. Helpers are being requested for 3v3 tournament.

Treasurer: Matt presents treasury report. Talks about Fun Day/Golf Tournament/Concession P+L report. Revenues down from year prior but costs are down for expenses. Chris motions to accept treasurer's report, Tim seconds and all in favor.

VP Facilities & Finance: Bill discusses set up for 3v3 fields and is asking for help for field step up. .Bill will ask Paul to repair holes in fields.

VP Boys Soccer: Dave reports spring 2012 Duncan and Jamie won their divisions. Gained 2 boys teams for spring, but lost 2 for fall. Scott Kelly's team is still at risk for shortage of players. Travel coaches meeting TBD for some time in August.

VP Girls Soccer: Coaches are asking for team discounts for mass online registrations for City Islanders Camp. Most age groups already completed and there will be no U8 play up team.

Concession: Jess ordered \$1,000 in coke product. Concession is still well stocked from Fun Day, will not need much for summer tournaments. Jess is seeking to reward girls who volunteered in concession during spring. Tim motions to compensate girls with \$75 visa gift cards. Matt seconds and all in favor.

New/Old Business: Kickoff Classic so far has 10 teams and have all paid by check so far. Nevin agrees to run college showcase with same details as 2011 with a date of 10/28. Chris motions, Tim seconds and all in favor. Tim mentions try out process and urges to follow specific outlines. Tim suggests forming committee for placements process. Jess suggests renting field space for vendors at summer tournaments/birthday parties/ flea markets. Chris motions to allow Jess to rent field space at \$20 per individual space and \$35 per business space. Josh seconds and all in favor.

Tim motions to adjourn meeting at 9:37pm, Chris seconds and all in favor.
