- > September 6-8 C/P meeting discussion
- Block Grant money usage (\$2500)
- Play-in games: January 4-5, 2014 @ T.B.D.
  - Needs to be decided in October meeting: to bid it should be affordable; we don't want to outprice teams from participating
  - Bids should follow District format (only Saturday and Sunday)
  - Bids should start at a reasonable time (not before 8am)
  - In the future sights might be rotated through the associations with double sheet facilities so rinks can plan.
  - Credential check #1 for winners and others wanting books checked

- > Team/player exceptions for Districts & States (example handed out at meeting on how to fill out a form)
  - Why/when they're needed
    - Less than 3 teams in a classification (Squirt, Peewee, Bantam, & Midget)
    - Less than 20 games as a team by first game of Districts
    - Less than 10 games with a team as a player by first game of Districts
    - Too many 2<sup>nd</sup> year players (sliding scale ratio)
    - Extend Midget intent to enter Districts until later in November due to MHSAA teams forming the first weekend of November.
    - Midget teams will most likely need an exception (see above)
