Commissioner Joe McInnis called the meeting to order at 2:27 pm. Introductions were made and roll was called (attendance listed above). A season wrap-up was distributed (attached).

CUP League Champions were announced (see wrapup) and trophies were awarded. A brief discussion of the season ensued. There were some complaints about officiating in Marinette-Menominee, especially at the Pee Wee level, that let some games get out of hand. There were no issues when M-M traveled to away sites.

Treasurer Harvey presented a brief financial report, which is also attached. Harvey mentioned that the referee clinics always conflict with Pee Wee football games in Iron Mountain. He was encouraged to bring the issue to the District Council's attention.

Milligan and Harvey mentioned that Association Dues are going to go up from the current \$50/association to around \$125, to cover the website hosting fees. Fall bills will reflect this change.

Milligan stated that the website worked well for teams entering their own scores. Directors agreed. A full report is attached to these minutes, including selected website analytics.

Officers were elected unanimously for 2014-2015: Joe McInnis, Commissioner; Jeff Harvey, Vice Commissioner-Treasurer; Walt Milligan, Secretary-Statistician.

Fall 2014 meeting was scheduled for Sunday October 19, 2014, at the Citizens Forum, Lakeview Arena, in Marquette.

This was the first year of the new website software, which requested that teams enter their own scores. I thought it went pretty well for the first year.

I did not hound anyone to put in scores, and only had to spend a couple of hours at the end of the year cleaning up the standings. (Some people mistakenly added games that were not CUP League games, and did not change the setting that would prevent those exhibition games from counting in the standings.)

As shown in the table below, the number of missing scores was higher than the last few years, but in the same range as the years before that. About 2/3 of the teams had a person who regularly entered scores. With some education and continued experience, this should get better.

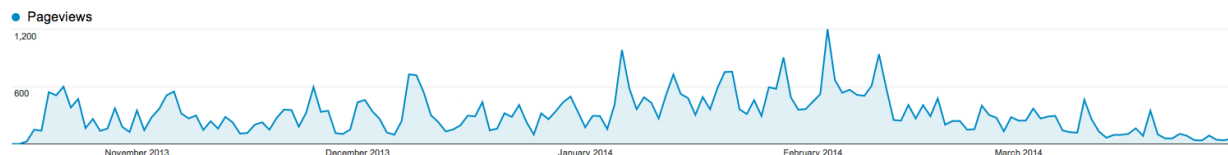
