

2015 WWF Junior Fargo Team Camp Information

The WWF Junior camps are open to all current USA Wrestling members residing in Wisconsin and enrolled in 9TH through 12TH grade. We encourage all wrestlers to participate for a spot on the Fargo Team. We will have wrestle offs in River Falls for those that did not win state in Freestyle or Greco-Roman.

The 2015 WWF Fargo Freestyle and Greco-Roman teams we will be hosting two camps.

Camp 1 - Madison

1. The first camp is June 25-28 in Madison. Both Freestyle and Greco-Roman teams will alternate practices during this camp.
2. Camp participants will stay at the Super 8 - Madison South 1602 W Beltline Hwy Madison WI 53713.
3. The cost of the Junior National Team Training Camp is \$300.
 - a. This includes the hotel stay.
 - b. However, participants are responsible for their own meals during camp.
 - c. There are a number of places to eat within walking distance from the Super 8.

Camp 2 – River Falls

1. The second training camp will be hosted in Baldwin/River Falls. At this camp the Greco-Roman Baldwin and Freestyle River Falls Teams will report to camps on different dates.
 - a. Greco-Roman camp participants will stay at River Falls Country Inn - 1525 Commerce Court, River Falls, WI 54022.
 - b. Freestyle camp participants will stay at River Falls Country Inn - 1525 Commerce Court, River Falls, WI 54022.
2. There is no cost for this camp as payment was made at the Madison camp.
 - a. However, participants are responsible for their own meals during camp.
 - b. There are a number of places to eat within walking distance from the River Falls Country Inn.

Fargo Team Qualifiers

1. For those who make the Fargo Team and are planning to attend the National Championships in Fargo, there is an additional \$100 fee per style. It covers the cost of the bus trips, hotel stay in Fargo, and the entry fee in to the tournament.
2. Uniform Package:
 - a. All uniform packages and parts must be purchased thru All-American Wrestling Supply.
 - b. No Uniforms will be sold at camp.
 - c. You can order your uniform by going to www.usawrestlingproducts.com/wiscteams
3. Please order your uniform ASAP to make sure you have it for Fargo. The uniform consists of a jacket, shorts, bag and red and blue singlet. If you choose to not order a uniform you **must** use the singlet provided by the WWF and return at the end of the tournament.

2. Register and pay when you come to camp.

5. July 25 Saturday - Return to River Falls (after medal rounds) for pick-up in River Falls (Country Inn, 1525 Commerce Court, River Falls, WI 54022).

Reporting to Camp

1. There will be four wrestlers to a room.
 - a. Greco participants will stay with fellow Greco participants and Freestyle with Freestyle.
 - b. If you want a specific roommate, make sure that you name him on the physical form that you are sending in.
2. The hotel offers a complimentary breakfast
3. You may also bring food that does not require refrigeration.
4. Each room is air-conditioned. All linens and blankets are provided.
5. Bring an alarm clock

WISCONSIN WRESTLING FEDERATION TEAM | PARTICIPANT CODE OF CONDUCT

Philosophy

The Wisconsin Wrestling Federation knows that the sport of wrestling can be a constructive force in the lives of our youth. The Federation is committed to providing participants in its activities with a variety of opportunities to build personal character, integrity, respect, responsibility and other skills necessary for them to reach their potential as citizens. While involvement in these activities is voluntary, it is also a privilege and athletes choosing to participate, take on extended responsibilities as special representatives of their state and wrestling community. These responsibilities hold the athlete to a high standard of conduct as a condition of participation and will help make participation in our programs a stronger learning experience.

Purpose

The purpose of this code is to define the rules for athletes participating on Wisconsin Wrestling Federation teams and to define the consequences for those individuals who violate these rules. Participants involved in Federation programs are expected to comply with these regulations, observe good order, and conduct themselves in a manner that will bring credit and honor to them and their state. All parties involved must always consider both the best interests of the individual and the integrity of the Wisconsin Wrestling Federation.

Athletes Code of Conduct

CATEGORY I

Athletes qualifying for or being selected to Wisconsin Wrestling Federation teams are expected to abide by the laws of the city, State or Country in which the travel/competition/training is taking place and must:

1. Abstain from ALL illegal activity including the use of alcohol, tobacco and the use of illegal drugs.
2. Abstain from sexual activities and/or sexual abuse.
3. Refrain from theft or vandalism of any property, hotel rooms, dormitories, training facilities, and equipment.

Any person subject to the terms and conditions of the code of conduct who violates **CATEGORY I** provisions shall:

1. Be sent home at the expense of the athlete and their family.
2. Reimburse the Wisconsin Wrestling Federation directly for any damages resulting from illegal activities.
3. Be banned from participating in any Wisconsin Wrestling Federation or USA
4. Wrestling event for the remainder of the USA Wrestling sanctioned season.
5. Be reported to the authorities.

CATEGORY II

Athletes qualifying for or being selected to Wisconsin Wrestling Federation teams must:

1. Refrain from using profane, insulting, harassing or otherwise offensive language.
2. Follow the rules of the Organizing Committee of the competition/activity.
3. Address fellow athletes, coaches, officials, volunteers, event organizers, spectators and others associated with the events in a courteous and respectful manner.
4. Abide by bed check and quiet hours designated by team coaches/leaders and remain in their assigned room unless granted permission to leave by a team coach/leader.
5. Meet at team assembly points on time and attend all team meetings.
6. Compete in the Wisconsin Wrestling Federation team uniform provided.

Any person subject to the terms and conditions of the code of conduct who violates **CATEGORY II** provisions is subject to the following:

1. Violation One: Coaches/leaders will assign punishment to suit the offense.
2. Violation Two: Coaches/leaders will assign punishment to suit the offense and parents will be notified.
3. Violation Three: Same as CATEGORY I consequences.

Your signature, as an athlete, on this form indicates that you understand and agree to abide by the Code of Conduct and philosophy. Your signature, as a parent/guardian, means that you have read and understand the possible penalties and enforcement of a violation. Any infractions hereafter will be considered a violation of the athletic code.
