Team rest- Teams can only participate in only 2 -on ice activities per day. No exceptions.

EMT'S- Are allowed to cover 2 games with facilities with 2 rinks, but no more then 2. No EMTS required for mites. Officials have to make sure EMT is present before start of game, Tournament Cord. Could state that they are present. Dan asked that each association get a copy of the Tournament rules and send to Nick and Dan.

USA Hockey Safesport- Everyone has to have a local coordinator. Each team shall have a person who has completed module. Next year every coach must complete module.

Mite rosters – Each team must be rostered separately.

No travel to Wisconsin except Superior.

Mites may travel outside district with permission from both directors.
