Expenses = \$1382.26. Long: \$4.00. Net profit = \$1532.70. **Pine Creek** - Gross receipts = \$0, Cost of prizes = \$0. Expenses = \$447.17. Short = \$0. Net profit = \$-447.17. **Valley High** - Gross receipts = \$2574, Cost of prizes = \$1950. Expenses = \$579.02. Short = \$12. Net profit = \$-71.00. Lawful purpose expenditures \$1564 which includes payment of Tax to MN Revenue. Bank report balance = \$38,031.85. Gross Profits (games) were \$8415. Gambling Site cash balances = \$4900.
