

**CENTENNIAL YOUTH HOCKEY ASSOCIATION  
2020-2021 PLAYER/PARENT CODE OF CONDUCT**



No person shall be eligible to register or participate in Centennial Youth Hockey unless properly enrolled and in good standing with the Association (CYHA). Should an individual be suspended during the year, that individual is ineligible to participate on their hockey team. Once that player's suspension is completed or the player becomes in good standing with CYHA, that individual shall be reinstated and eligible to compete on their hockey team.

Players and/or Parents may be asked to leave the rink/arena or be suspended from team practices or games for reasons including, but not limited to the following:

1. Any conduct that does not represent CYHA in a positive light. As players and parents, you are representatives of Centennial Hockey. You should conduct yourselves responsibly and appropriately at all times;
2. Swearing or the use of any foul, abusive, derogatory or inappropriate language before, during or after a game/practice involving any league or rink official, players and coaches from other teams, teammates and/or their parents;
3. Any bullying behavior, whether verbal or physical;
4. Any chemical use that is illegal, including but not limited to alcohol and any tobacco products;
5. Willfully defacing or damaging any arena property;
6. Theft from teammates or other players/teams;
7. Cell phone or camera usage in a locker room. These items are strictly prohibited in any locker room and could carry criminal and civil sanctions as well as District 10 and Minnesota Hockey penalties;
8. Any fighting at a Centennial Hockey related activity;
9. Any conduct detrimental to your team or CYHA;
10. Failure to follow all rules and guidelines (including COVID-19) posted at any arena visited;

The first violation of this Code of Conduct may result in a suspension for two games or two weeks, whichever is longer. A second violation may result in a suspension for six games or three weeks, whichever is longer. A third violation will require an appearance before the Board and Board approval to be reinstated. These sanctions are in addition to any consequences that any team may impose for violations of team rules. **IMPORTANT: THESE ARE MINIMUM CONSEQUENCES; ADDITIONAL CONSEQUENCES MAY BE IMPOSED DEPENDING ON THE SERIOUSNESS OF THE VIOLATION. THESE ARE IN ADDITION TO ANY CONSEQUENCES IMPOSED BY DISTRICT 10, MINNESOTA HOCKEY OR USA HOCKEY.**
