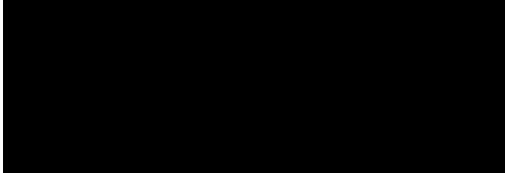

I have no experience as a board member. I have several hours of setting up fields and working the concession stand. I was a member of the Red Cross Disaster Action Team for 5 years. I set up food delivery for Blessings in a Back Pack with my company. We've been delivering the food from Wal-Mart to the Blessings warehouse every month. We've been delivering their food for 2 and a half years. I've also been active with Habitat for Humanity. I helped work on the most recent build, was the lead pilot car for home delivery and helped pour the foundation for a very deserving family. They have asked me several times to be on the board, but have never committed my time, yet.

**Most recent volunteer positions you have held:**

GGFA, I was a grunt, like everyone else. Doing field work and concession stand. Habitat for Humanity, I was the lead pilot car and main contact for moving the house, and I was in charge of the siding crew. For a year and a half, I set up all food deliveries and was the main contact person between Blessings in a Back Pack and my company. For 5 years I was on call one week a month for the Red Cross. I only got called out once to a structure fire. The fire department and the ambulance are there for the fire and everyone's safety, Red Cross is there for just the family. We would be present to make sure they had somewhere to stay until they could get everything situated. We had access to several options from missing glasses, prescriptions and clothing. My time with the Red Cross was amazing, all the training and knowing how big of a difference we make during a families most vulnerable moment.

I believe in accountability and choosing the morally right decision. It's time that we get a board that thinks about the girls and what's best for them. We aren't here for the drama, and that's what it's been. It's time to take GGFA from being an ok organization to a World Class Organization and get more organization in the organization.
