Bath Youth Club Indemnification, Parent Responsibility & Code of Ethics

1. I agree to indemnify and hold harmless the Bath Youth Club Inc. (also known as the Bath Youth Club, BYC, Bath-East Allen Youth Club, or BEAYC) and its respective officers, agents, coaches/volunteers from any loss, damages, expenses and liabilities (including legal fees) by reason of property damage and/or personal injury including death arising out of participation in any BYC Inc. sponsored activity.

2. While all BYC, Inc. sports require certain levels of physical activity, I attest that a legally licensed physician has not determined that the sport(s) that the above player(s) have registered for would be harmful to their health and/or well-being while participating in the sport for which he/she has registered for.

3. I agree to be responsible to pick up and deliver the player(s) to all practices, games, competitions and activities. I will indemnify and hold harmless any individual(s) who perform this task due to my absence or my request. I will return in good condition an uniform or equipment issued to my child(ren)

4. (Currently Not-Applicable) I understand that each child must participate in the required fundraiser (except 3rd or more child signing up for the same sport) by purchasing fundraiser(s) at the time of registration. I also agree to participate in any per sport fundraiser as approved by the BYC, Inc Board of Directors.

5. I agree to fulfill my obligation in some capacity as required by the BYC, Inc as it pertains to parents' mandatory volunteerism (I.E Scorekeepers, door monitors, team parents, ect.)

I will promise to help my child enjoy the youth sports experience within my personal constraints by assisting with coaching, being a respectful fan providing transportation or volunteering for whatever I am capable of doing. I agree to reimburse BEAYC, Inc. for any fines incurred by myself, spouse and/or children imposed by a sanctioning league by our actions.
