1. Call to Order (Molly Gill)
 - a. Called to order at 7:38pm
 - b. In attendance: Molly Gill, Kirsten Gackowski, Sara Halverson. Khumbalani Moyo, Kelsey Kottek, Jenie Evans, Susan Engle, Lynn McCaffrey*, Chris Bowles* (*non-voting committee members/advisors)
2. State Chair Update
 - a. Molly Gill reviewed the State's current financials. We are currently in the black with little reserve for next year.
3. Judge Selection for upcoming championship meets (Molly Gill)
 - a. Optional State: Molly Gill reviewed the list of judges available for the Optional State meet for later review and voting by the committee. There are a limited number of judges available.
 - b. Spring Compulsory State: A list is being compiled of available judges and will be distributed for an email vote in early December.
4. State Clinic for Summer 2016 (Molly Gill)
 - a. July 30 and/or 31, 2016 at National Academy of Artistic Gymnastics in Eugene.
 - b. Clinic is for compulsories only at a cost of approximately \$50/gymnast.
 - c. Schedule will be two sessions (9a-1p for Level 3 and 2p-6p for Level 4/5).
 - i. Session max of 60 athletes
 - d. The committee discussed possible clinicians and will start reaching out to those recommended. Additional recommendations are welcome.
 - e. The committee also discussed possibly awarding partial scholarships to the compulsory clinic to compulsory gymnasts placing in the top three all-around as well as event champions at both state meets.
 - f. A flyer with more detail will be created in early 2016.
5. Xcel State Invitational (Molly Gill and Kirsten Gackowski)
 - a. Hosted at The Gym-Nest Ltd. by the the committee; April 16-17, 2016 (may be two days, depending on response)
 - b. This meet will have two judge panels for all levels and sessions.
