

WAIVER OF LIABILITY



I, the undersigned participant, am hereby enrolling in a program of strenuous physical activity including, but not limited to, speed training, weight lifting, plyometrics, and the use of various aerobic conditioning and strength training machinery and equipment offered by Utah Speed Academy.
