ACCIDENT WAIVER AND RELEASE OF LIABILITY FUTSAL TOURNAMENT DECEMBER 26-29, 2018

I hereby assume all of the risks of participating in this Futsal Tournament, including by way of example and not limitation, any risks that may arise from negligence or carelessness on the part of the Released Parties (as defined herein), or from dangerous or defective equipment or property owned, maintained or controlled by them, or because of their possible liability without fault.

I certify that I, or my participating child, am physically fit and have not been advised to not participate by a qualified medical professional. I certify that there are no health-related reasons, issues or problems which preclude my participation in this Futsal Tournament. I acknowledge that this Accident Waiver and Release of Liability will be used by the organizers of the Futsal Tournament (Blackhawks Soccer Club) in which I (or my participating child) may participate and that it will govern all actions and responsibilities at said Futsal Tournament.

In consideration of my application and permitting me to participate in this Futsal Tournament, I hereby take action for myself, my executors, administrators, heirs, next of kin, successors, and assigns as follows:

- (A) I HEREBY WAIVE, RELEASE, AND DISCHARGE the Released Parties from any and all liability, including but not limited to, liability arising from the negligence or fault of the Released Parties for my death, disability, personal injury, emotional distress, property damage, property theft, or actions of any kind which may hereafter occur to me including my traveling to and from this Futsal Tournament. THE FOLLOWING ENTITIES OR PERSONS ARE RELEASED PARTIES: Los Rios Community College District-Cosumnes River College, Blackhawks Soccer Club Inc., and/or their directors, officers, employees, coaches, agents, representatives and volunteers.
- (B) I HEREBY AGREE TO INDEMNIFY, HOLD HARMLESS, AND PROMISE NOT TO SUE the Released Parties from any and all liabilities or claims made as a result of participation in this Futsal Tournament, whether caused by negligence or otherwise.

I acknowledge that this Futsal Tournament may carry with it the potential for death, serious injury, personal injury, emotional distress, and personal loss. The risks may include, but are not limited to, those caused by terrain, facilities, temperature, weather, lack of hydration condition of participants, equipment, vehicular traffic, actions of other people including, but not limited to, participants, volunteers, spectators, referees, and coaches.

I consent and agree that Blackhawks Soccer Club Inc., and/or its coaches, agents, representatives or volunteers may take photographs or digital recordings of me as a participant during this event and use these photographs or digital recordings in any and all media for training or promotional purposes. I further consent that my identity may be revealed therein or by description text or commentary. I waive any rights, claims or interest in such photographs or digital recordings, and I understand that there will be no financial or other remuneration.

This accident waiver, release of liability and image release shall be construed broadly to provide a release and waiver to the maximum extent permissible under applicable law.
