**Meeting Minutes**

May 13, 2014

**Call to order:** Josh Burnham (SACC) called to order the regular meeting of the SAC at 8:45 p.m. on May 13, 2014 via teleconference (1-605-475-4000 ext.305163).

**Roll call:** The following persons were present: Josh Burnham, Denis Berry, Denny Allen, and Sharon Mozer.

**New Business:**

1. Gym of the Year award presented to – Lone Mountain ~
2. Montana judges continue to get positive feedback from judges at Regionals, Westerns, and Nationals.
3. Western Championships ran well compared to previous years. Regionals had positive feedback from judges and coaches
4. Montana gymnastics is improving each year. This year, gymnasts from the state placed in all three championships (Regional, Westerns, and Nationals).

**Old Business:**

1. State Camp
  - a. 64 gymnasts are registered and a few more are coming from Mismo. We will have around 68-70 gymnasts. Three all-around state champions have registered for camp
  - b. \$12,700 have been collected for camp, with \$1,500 more to collect
  - c. SAC USAG account has \$27,000 as of 5/13/2014
  - d. SAC anticipates spending \$13,000 on camp
  - e. BGS will host camp for \$2,000.00 and will apply for sanction status (\$80.00). The state will reimburse \$80.00 sanction fee to BGS
  - f. Clinicians are Steve and Sue Arkell, Quinn Shannon, Jeanine Henneford, Dr. Allison Arnold, and a dance choreographer
  - g. Lodging for clinicians will be at the Hilton Garden Inn (close to gym). Cost is \$150/day (originally \$235.00/day). We will pay an extra \$10/person for breakfast at the hotel. We have four rooms reserved
  - h. Bus will be through the school bus company. This will meet our budget.
  - i. Montana coaches to work camp are: Keeley Lowney, Becky Rammell, Chris Bushard, Sharon Mozer, Denny Allen. We're suggesting one montana coach with a clinician
  - j. Dorm chaperones are: Kinzie Klien, Michaela Westfall, Sharon Mozer, and Chealsea Hunthausen
  - k. Activities: Thursday night is activity and game night, Friday is pizza at the gym then to the Reef for swimming
  - l. Friday night dinner for clinicians and coaches ~ Denny will organize a dinner at his cousin's home – maybe an elk barbeque
  - m. Clinic rotations to follow at the next meeting ~ Wednesday, May 28, 2014
