A number of very important positions will need to be filled for next year, we have a number of great Position of Special Function (PSF) volunteers who are moving on, including our Registrar, JanEl Daul, and our Accountant, Dawn Krause. PSF elections will be in May, Board member elections will be in April and there will be 5 openings.

12. Scheduling

a. Open Skate – we have an agreement with the City that we need to provide a minimum of 150 hours. Discussed options for making sure we obtain the hours. Could have an Open Skate on Feb 23rd, an in-service day for the students. Will be moving practices and game times around to gain additional hours.
