- All coaches and club staff working with juniors require CHRVA memberships with a completed Background and Safe Sport certification. CHRVA recommends a copy of each membership card is maintained in a binder to display “Due Diligence” and verification of membership, background and Safe Sport status.
- CHRVA prefers Beach Club Coaches to have BCAP certification; IMPACT training is a required minimum.
- All participants require CHRVA memberships. An active membership number is required.
- A list of all locations planned for use by the organization for practices, training, clinics, or tournaments must be listed.
