Rules

1. 20 minute games (10 minute halves) running clock
2. 1 timeout per team (30 seconds)
3. No full court press
4. No overtime or ties (half court shootout, first team to make one in 2 minutes wins)
 - a. If still tied after 2 minutes of half courters, move to three pointers
 - b. If first team makes it the second team must make their next shot
 - c. Rock, Paper, Scissors determines which team goes first
5. No dunking (immediate ejection)
6. No flopping
7. No swearing
 - a. Automatic technical foul
8. 4 personal fouls per person
9. Two minute halftime
10. 7 team fouls before bonus
11. All normal basketball rules apply
12. Rock, Paper, Scissors, Shoot determines who wears pennies or not
13. Double Elimination
