## **Summary of Membership Requirements**

### **Applying for Membership**

To become a member of Limestone Trout Club you must be sponsored by a member, submit a membership application, and have an interview with the Membership Committee. After the membership interview, the Membership Committee will make a determination regarding your membership. If accepted, you will be invited to become a member of Limestone Trout Club and will be asked to pay membership fees. If you do not know any club members we will introduce you to a member who will act as your sponsor and guide you through the process.

### **Classes of Membership**

There are four general membership categories:

1. Regular Stockholder Member
2. Senior Member – Stockholder 75 years old and over.
3. Junior Member – Non-stockholder less than 36 years old.
4. Trial Member – Non-stockholder, valid for one fishing season.

### **Membership Privileges**

1. Members have full use of club facilities during the season.
2. Family Members have full use of club facilities including fishing privileges during the season but must be accompanied by the Member.
3. Members may have any number of non-family guests per day but only three fishing guests per day.
4. Non-family guests may only be invited to fish for three visits per season.

### **Membership Financial Requirements**

1. **Annual Dues** – Set by the Board of Directors annually and cover operational expenses and infrastructure enhancements.
2. **One Time Fee** (All membership classes) – Includes processing and a copy of the history of Limestone Trout Club, *Set in Stone*.
3. **Stock** (Only for Regular and Senior Members)
  - a. Each Stockholder member is required to purchase five shares of **common stock** with a par value of \$500.00 each. Two of these shares are non-refundable and have a 10% tax.
  - b. Each Stockholder member is required to purchase one share of **preferred stock** with a par value of \$450.00 plus 10% tax.

- c. Three common shares and the preferred share are redeemable at par value upon termination of membership as provided in the Limestone Trout Club bylaws.
4. **Junior Member Initiation Fee**
- a. Junior members must pay an initiation fee \$750.00 plus 10% tax.
  - b. On turning 36 the member becomes a Regular member and must purchase stocks. The initiation fee is applied to the stock purchase.
