



2019 SC AAU District Championship Bid Information:

2018 SC AAU District Championship– Date: April 26-28, 2019

District Championship Venue:

Must be large enough to adequately space two full sets of equipment. This includes adequate seating, judges and coaches hospitality, adequate parking and a separate awards area.

District Championship Theme:

The meet director must select an appropriate theme. The facility must be decorated to provide the District Championship Atmosphere. The theme must be pre approved by the AAU Chairman.

Gymnast Gift:

The meet director must select an appropriate athlete gift to be given to each participate at the District Championship meet. This is expense is completely the responsibility of the host club. The Gymnast gift must be approved by the AAU Chairman.

SC AAU District Championship Meet Flyer:

Will be provided and sent out by the AAU Chairman

SC AAU Rules and Modifications:

The meet director must comply with all of the SC AAU Rules and Modifications published by the SC AAU State Chair.

Entry Fees: \$60.00 per gymnast \$40.00 Team entry per level

Judges:

SC AAU District Championships will use two judge panels for all levels and a separate meet referee.. All South Carolina Judges must have a current AAU membership. The selection of judges for the District Meet will be completed by the AAU chair, however, the host club will be responsible for the applicable request for judges fees.

Awards:

South Carolina AAU requires 100% awards for event and all Around for all Levels. All Age groups must be 12 or less with no more than a two to three year age span. 100 % Team awards are also required for all teams that submit a team entry.

AAU Sanction:

The AAU Chairman will be responsible for obtaining the SC AAU District Championship Sanction, the host club will reimburse the State Chair for this expense. Certain facilities require 3rd party insurance. It is the host club's responsibility to notify the State Chair if this insurance is needed for the venue.

AAU Memberships:

The host club must obtain a AAU club and Non athlete membership

SC AAU Competition Meet Tax:

\$1.00 per gymnast Meet tax payable to the AAU Chairman at the conclusion of the event.

AAU District Championship Schedule, Age Groups and Awards:

Must be approved by the AAU Chairman before it can be published

6. Pay a \$1.00 per gymnast meet tax to the SC AAU State Chair
7. Must have a reliable computer scoring system/ operator
8. Must have a music manager: Dave Gale preferred
9. NAWGJ Judges will be requested by SC AAU Chair
10. All judges request fees will be paid by the host gym club
