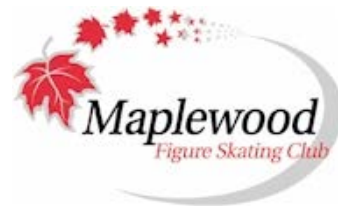

Subject: **MEMBERSHIP RENEWAL**



This year we will again be utilizing our online membership program on the club website for the 2018-2019 MFSC Membership. Go to [www.mfscskate.org](http://www.mfscskate.org), and if you have not done so already, click on "Create an Account", set up your account & log in. Once logged in, from the home page click on "Membership" and go from there. With this online membership, you will have the option of paying with a credit card online, or turning in a check.

It is not necessary to fill out & turn in hardcopies of the renewal forms (although they are available in PDF form on the website for your review). The online renewal process includes entering the required data for the forms. All Maplewood skaters (home club and associate members) must complete the online renewal and pay the membership dues by **May 31<sup>st</sup>, 2018**. After the May 31<sup>st</sup> deadline, a \$20.00 late fee will automatically be added to the membership cost. **The only form that will require a hard copy to be filled out and signed by hand will be the US Figure Skating Safe Sport Code of Conduct.**

Benefits of a MFSC membership include reduced pricing for MFSC contract ice and test sessions, along with participation in the MFSC Christmas Party, Spring Show and Spring Banquet!

Rulebooks are now available on the USFS website as a free download. Go to [www.usfsa.org](http://www.usfsa.org) then go to Technical Info and then Rulebook.

We will be enforcing our late payment policy for all areas of the MFSC. It is as follows:

**Payments 30 days late** – a \$20 late fee will be assessed. The skater will not be allowed on MFSC ice, to participate in the MFSC Spring Show, any competition or test session.

**Payments 60 days late** – skater will be removed from the MFSC roster and registered as a member not in good standing with US Figure Skating. To be reinstated, you will need to re-submit your membership packet with a \$125 reinstatement fee.

If you are not planning on renewing your membership with MFSC, please let me know so I do not send you a reminder letter. If membership is not renewed, you will not be allowed on MFSC ice as of July 1<sup>st</sup> 2018.
