# **Guest Speaker- MAHA President George Atkinson-**

George summarized the summer meeting(s).

Discussed new hire, first time MAHA has had a paid employee. Applications are being accepted. New hire will help associations and directors. Emphasis on Safesport at the summer meeting. New hire will help with influx of Safesport reporting.

2020 background checks will be National background checks, will cause fees to increase.

On ice safety. Pay attention to new points of emphasis on player safety on ice.

Shortage of refs. Stop abusing refs. Zero Tolerance policy.

# **Guest Speaker- Steve Stapleton-MAHA Attorney**

Steve re-iterated the new Safesport updates from the summer meetings. Steve gave a handout to associations to take back to their coaches and parents. Brief discussion on the paper trail for Safe sport reporting and jurisdiction. Mandatory reporting. 2002 birth year and older need to complete Safe sport in order to be placed on a roster.

Steve emphasized some obvious points to remember for coaches- no one-on-one meetings with players, no texting kids without parents on the text thread. No electronic devices in locker rooms. Make sure locker room monitors are always present.

## **Amanda Gobert- MAHA Registrar**

Make sure your midget/girls teams know to have their players 2002 and older, complete Safesport.

Everyone on Association boards need Safesport and background checked. Association registrar's need to create rosters for their Board of Directors. Association teams will not be approved until the Association Board roster is complete.

If you have teams where kids are billeted, every adult member of that billet household needs to be background checked, Safesport compliant.

All USA Hockey sanctioned programs need to be rostered. From mini-mites, to timbits, to developmental programs, all teams/groups need to be rostered. No exceptions on requests for birth certificates.

Michigan Hockey Associations must have a hard copy of the concussion form for every player.

Teams who are National Bound, need to keep a hard copy of the "consent to treat" form. The association does not need these forms, the team will keep the consent to treat forms.

House rec no longer exists in the portal system for rostering. It is now referred to as Tier III.
