### Academic Guidelines for the Option of Waiving One (1) credit of Physical Education:

Students **MUST** complete an additional one credit in English, social studies, mathematics, science or health in lieu of one (1) credit of physical education when they participate in a District sponsored or WIAA-sanctioned athletic team listed in the Menomonee Falls High School Student Handbook for at least 95% of the season. A required course or credit may not count for the one credit substitution course; the one credit substitution course must be in addition to the minimum graduation credit requirement for the English, social studies, mathematics or science subject areas. Physical Education 9 and Physical Education 10 are required courses to which the one credit substitution cannot be applied. Participation in the sport itself does **NOT** constitute a course and does not qualify for any high school graduation credit. See MFHS Physical Education Waiver Information form for criteria.
