I understand that the risk of becoming exposed to and/or infected by COVID-19 by participating in the activity of West Melbourne Youth Football and Cheerleading may result from the actions, omissions, or negligence of myself and others, including, but not limited to, West Melbourne Youth Football and Cheerleading board members, volunteers and other individuals. I, the parent/guardian of the named participant, voluntarily agree to assume all the foregoing risks and accept sole responsibility for any injury, illness and/or death to the named participant, my family or myself. On behalf of the named participant, I consent and agree to comply with all preventative measures required by West Melbourne Youth Football and Cheerleading, including, but not limited to, temperature checks, required masks, and hand washing. I understand that failure of the named participant to comply with any request from West Melbourne Youth Football and Cheerleading in relation to any preventative measures may result in the named participant's expulsion from West Melbourne Youth Football and Cheerleading.

**On behalf of the named participant, my family or myself, I hereby release, covenant not to sue, discharge, indemnify and hold harmless GWMAA, and West Melbourne Youth Football and Cheerleading, its board members, representatives, agents and assigns, of and from any and all claims, including all liabilities, actions, damages costs or expenses of any kind arising out of or relating to the named participant's participation in West Melbourne Youth Football and Cheerleading.**
