To be eligible for nomination as a EKVC Director, a person must:

- a) commit to attending Board of Director meetings and faithfully serve the needs of the members through active participation in committee work,
- b) be 18 years of age or older,
- c) be a Member of the Society,
- d) have the power under law to contract,
- e) not been convicted of an offence in connection with the promotion, formation, or management of a corporation or an incorporated entity, or an offence involving fraud,
- f) commit to a criminal record check.

The Board will meet twelve times a year, with a requirement that a minimum of 9 meetings in the year are attended. Each meeting will be 1 to 1.5 hours long with an agenda and back up documents being provided for review a minimum of a week prior to the meeting. As this is a working board, you will be asked to select a job description that best fits your skill set such as; Program Coordinator, Internal Communication Director or External Communication Director to name a few. Part of the responsibility of these positions will include heading committee(s) members to fulfill duties as assigned to the position. Please be aware that some positions are a set term of minimum 1 year and up to 3 years.
