- If a team does not accept their bid for post season play, invitations will be sent to the next team, in order of ranking, until a tournament is filled.

  - Thursday, February 28: Last Day Bids can be Accepted for Adult Division III (24 hours from invitation receipt)
  - Sunday, March 24: Last Day Games are considered for Adult Division III seeds
