**Michelle brought up a concern about gyms not reporting the number of participating athletes correctly, and not paying the correct amount of competition fees. There is one gym which has repeatedly reported and paid the wrong amount even though they were notified of the error.**

**Motion by Marian Dykes and 2<sup>nd</sup> by Stacey Harris – Underpayment of competition fees by 10% or more will result in the gym being required to pay double the expected competition fees of \$2 per gymnast. Underpayment by 9% or less will require the gym to pay the underpayment amount. A new competition fee tax form will be posted on the Georgia USAG website, and must be completed and sent to Gwyned Bius along with the competition fee check.**

**Michelle is asking that a check box be added to the gymjas.com website that will require that meet directors indicate that they understand the competition fee requirement before adding a meet to the calendar.**
