2. **Report of Officers**

B. Recording Secretary - Hall of Fame Nominations are due before the February meeting. Each nomination should include the individual, a brief history of their participation in the MRC and a brief description of why they should be in the Hall of Fame (nominator must present the person at the induction meeting, which will be in March, unless an inductee has a conflict and then we will schedule that person's induction at a subsequent meeting). Qualifications are in policy posted on website.
