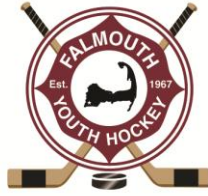

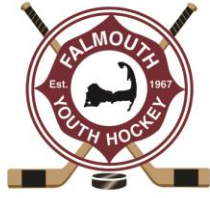

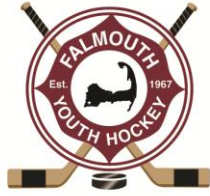


## Mission Statement

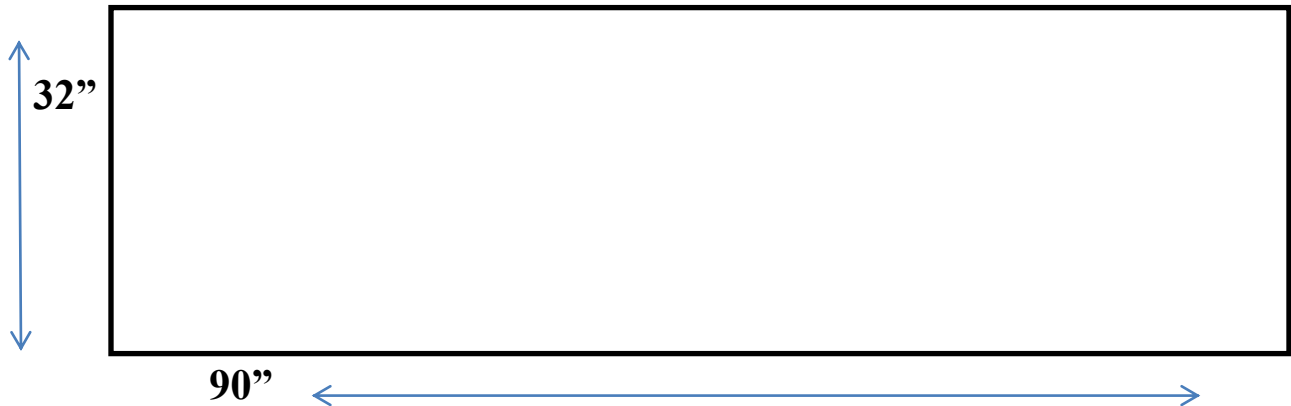

## SPECIFICATION SHEET

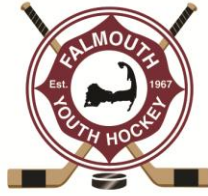
1. Advanced artwork is printed using a 4-color process allowing for complete full color graphics. Background will be printed white.

### RESPONSIBILITIES

Falmouth Youth Hockey League will provide the marketing, prospecting and selling of ad sales for the dasher board’s signage. Arena personnel will install the signs in the designated locations on the dasher boards and keep signs readable and attractive. This means cleaning with puck-off as necessary. All ad copy will be reviewed and approved by Falmouth Youth Hockey League and the Board of Governors. (Corporation)

### TYPES OF ADVERTISERS

Local and regional advertisers include: Automobile Dealers, Banks, Sports Retailers, Real Estate Agencies, Insurance Agencies, Restaurants, etc.

National advertisers include: Athletic equipment manufacturers, snacks, soft drinks, telecommunications, overnight carriers, financial services, Internet service providers, etc.

### PAYMENT PLAN

Payment is due in full upon execution of dasher board agreement. Yearly renewals will be paid in full prior to contract anniversary date.

Dasher board signage will be at a minimum, a two (2) year commitment.

Agreement terms start the date the contract is signed and payment is made.

### **THE CLIENT AGREES:**

1. To provide the CORPORATION with the advertisement copy for the dasher board sign.
2. That the yearly amount due will be paid in full, after CLIENT approves the ad copy.
3. The CORPORATION has the right at its discretion to take the CLIENTS sign off the dasher boards if the CORPORATION finds that the CLIENT has caused in any way harm or embarrassment to the CORPORATION, or if any amount due is not received as per the agreement.

### **BOTH PARTIES AGREE:**
