MSLFSC Board Member Eligibility: A nominee for MSLFSC Board of Directors shall be a Home Club member in good standing who has been a Home Club member for at least six (6) months. A Home Club member is a dues paying member of record who is 18 years of age or older.

Please note that according to MSLFSC bylaws, any guardian who has a Free Skate 3 level or above skater must participate on the board for a minimum of two (2) years. If board positions are open, you will be asked to serve on the board.

If you are interested in running for a position, please complete the attached form (front and back). Forms are due by **Sunday, January 27, 2019**. The Nomination Committee will make their recommendations and the MSLFSC current board of directors will finalize their decision by February 3, 2019. At that time, the 2019-2020 board will be listed on the website. While many of our current board members will apply to remain on the board, there will be several openings due to attrition.

Please consider volunteering for these important roles within MSLFSC. These volunteers are an integral part of keeping the club running and supporting all of our skaters. All members of the MSLFSC Board of Directors are expected to participate in monthly board meetings, minimize personal motivations or conflicts of interest, and to act in the best interest of MSLFSC.
