LAND DEPOSIT POLICY

- * \$5,500.00 per GROUP initial deposit due within 30 days of booking
- * \$500.00 per person 2nd deposit due June 21, 20126
- * \$800.00 per person 3rd deposit due September 20, 2026
- * Final payment due December 18, 2026

AIR DEPOSIT POLICY

- * \$500.00 per person initial deposit due within 2 weeks of booking.
- * Final payment due in conjunction with Land payments.

FLIGHT SCHEDULE

LAND TARIFFS

All ground transportation and hotel rates are based on 2027 pricing but subject to change until deposit is received to guarantee the space.

LAND ONLY PASSENGERS

Although Airfare is not included in this current program, all transfers will be based on a time designated by the group leader. Typically, these times will be predicated on a flight schedule selected. Should anyone wish to make their own flight arrangements separate from the group's selected flights, these passengers will be considered "Participants Pursuing Personal Itineraries" or PPPI.

PPPI: It is imperative that any and all people falling under this category be fully aware of the following facts pertaining to the tour program:

1. Transfers between airports and hotels are always arranged for the main group and are coordinated with the main group's flight itineraries.
2. The transfers also pick up and drop off only at airport terminals that are in the main group's itineraries. Transfers do not stop at alternate terminals for pick-ups or drop offs.
3. It is the responsibility of such PPPI passengers to coordinate their flights with the group and for them to be at the appointed place and time that the group is being picked up.
4. There can be no special arrangements made for PPPI passengers for alternate pickups or drop offs by the transfer companies involved.
5. All of the above is equally applicable to any luggage that such PPPI passengers are bringing.

CANCELLATIONS: Charges for cancellations depend on the date that the written notice of cancellation is received in our office and the departure date of the tour. Those dates and charges are as follows:

- Up to 90 days prior to departure NO PENALTY
- Between 89 & 60 days prior \$ 750.00 PER PERSON *
- Between 59 & 46 days prior \$1250.00 PER PERSON *
- After 45 days prior FULL PENALTY
- NO SHOWS ARE NON-REFUNDABLE

* PLUS ANY OTHER NON-REFUNDABLE CHARGES FOR AIRLINES, HOTELS AND SUPPLIERS.

NO REFUNDS FOR UNUSED ACCOMMODATIONS OR SERVICES

PLEASE NOTE THAT ALL CANCELLATIONS MUST BE RECEIVED IN WRITING BEFORE CALCULATING THE AMOUNT OF REFUND DUE.

SUBSTITUTIONS: In the event that a canceling passenger is able to provide a substitute for that canceled space there will be an administrative charge of \$100.00. However, this fee only takes affect within 60-days prior to departure. Any name changes prior to this point are free of charge. All substitutions must follow the same itinerary as the passenger they are replacing with the exception that there may be occasions where the substitute may wish to purchase additional options.

In this event, we will make every effort to satisfy such requests. SUBSTITUTIONS CAN ONLY BE MADE IN ACCORDANCE WITH THIS PROVISION UP TO 45 DAYS PRIOR TO DEPARTURE. WITHIN 45 DAYS OF DEPARTURE, ALL TARIFF RULES AND PENALTIES WILL APPLY.

AIRLINE SEATING: It is customary for the airlines to allocate a section (or block) of seats when booking groups. It is understood that the group is usually seated in this block of seats and requests for aisle or window seats cannot always be accommodated due to the limitations required by the seat block.

Requests for special seats can be taken, but cannot be guaranteed. Exit row and/or bulkhead seating can only be assigned at the airport.

GROUP AIR: Although not included in this program, you should be aware that in order to qualify for group air you must have 10 or more persons traveling together on the same itinerary. If there are persons requesting deviations from the group or the group reduces to less than 10 passengers, the airfare may have to be adjusted accordingly for those persons involved.

ITINERARY CHANGES, DEVIATIONS: Passengers requesting an itinerary that differs from the group must submit their request in writing up to 90 days prior to departure. Holidayz will, in turn, advise on their options as well as any additional costs that may apply. However, it must be noted that airline tariffs will only allow a maximum of 10-20%, depending on the airline involved, of group total to deviate from the original confirmed itinerary. Also, please note that deviations can be requested for return flights only

ENTRY REQUIREMENTS: All U. S. Citizens participating in this tour program are required to have a U. S. Passport valid for at least 6 months beyond the return date of the tour. Any non-U. S. Citizens participating in this tour must check with the appropriate consulate for all countries being visited and transited, to ensure that they have met all entry requirements. It is the participant's responsibility to be sure that all proper entry requirements are met and that they have all the appropriate documents necessary.

**If we don't receive a seating chart by the 60-day deadline, the list will be sent according to the rooming list.
