**Amending Women's Rules and Regulations - as outlined in the [NWBA Women's Division Guidelines](#)**

*Section 1:*

*These Rules and Regulations may be amended at any Annual Meeting by a majority vote of the delegates present and voting, provided that the proposed amendment shall have been submitted in writing to the Secretary of the Division four weeks prior to the Annual Meeting. (March 29, 2026)*

*Section 2:*

*The Secretary shall email a copy of the proposed amendment to all members of the Division not later than two weeks before an Annual Meeting. (April 12, 2026)*

*Section 3:*

*A proposed amendment to the Rules and regulations may be amended at the annual meeting by a majority vote of the members present and voting, provided that the amendment to the proposed amendment shall have been submitted in writing to the Secretary prior to one o'clock in the afternoon on the day preceding the final business session.*

*Section 4:*

*The WD Executive Committee may propose amendments to amendments at the time of the Annual Meeting without the procedural requirement described in Section Three for this Article, provided that in each instance, the proposed amendment has been approved by a majority vote of the Executive Committee and copies are distributed before or during the business session.*

*Section 5:*

*Unless otherwise specified, all amendments shall become effective on the first day of September following adoption by the Annual Meeting.*
