SKOMOR S.C. PARTICIPATION AGREEMENT AND LIABILITY RELEASE

Contingent upon acceptance by SkoMor Soccer Club ("Club") of the above-named Player in the Club's Soccer Program ("Program") and, in sole consideration of the acceptance, the Player and his or her parent/guardian, personally and on behalf of the Player, agree to the following:

- 1. The Player and parents/guardians agree to participate in the Program and the player shall not participate in any other club sanctioned and governed by the IWSL and/or YSSL during the Club season. Participation in any AYSO, school, or national team is permissible and does NOT violate this agreement.
- 2. The Player understands that the Club shall have exclusive right to establish and modify standards of conduct, behavior, and performance of the Player in the Program, and to require the Player's strict compliance with the standards as a condition for continued participation in the Program. If the Club determines, in the exercise of its sole discretion that further participation of the Player in the Club is inconsistent with the best interests of either the Player or the Club, then the Club shall have the right to terminate the Player's participation in the Program, without any formal hearing.
- 3. The Player is aware and understands that while the Club takes precautions for the safety of persons and property in connection with participation and the Club will provide coaches to supervise practice, training, and matches, soccer is a physically demanding contact sport and events may occur that include, but are not limited to, bodily injuries while playing in a match or practice, including injury caused by another player, coach, parent, or other spectator, or field condition, including injuries to muscles, tendons, joints, and bones. Players may suffer concussions or other head trauma resulting in temporary or permanent cognitive or physical impairment; property may be damaged or destroyed; players may be injured traveling to or from a match, tournament, or practice, and that bodily injury, property damage, or death may result from participation.
- 4. The Player acknowledges that he or she has voluntarily and without compulsion or compensation by the Club decided to participate in the Club. As a condition of that participation, the Club requires the Player to execute and deliver this Agreement and, except as set forth herein, the Club has made no representation or warrant, express or implied, of any kind whatsoever related to the subject matter of this Agreement.

PLAYER HEREBY RELEASES, WAIVES, DISCHARGES, AND COVENANTS NOT TO COMMENCE LEGAL ACTION AGAINST THE CLUB, THEIR OFFICERS, DIRECTORS, EMPLOYEES, MEMBERS, AGENTS, CONTRACTORS, AND REPRESENTATIVES (THE "RELEASED PARTIES") FROM ANY AND ALL CLAIMS, DAMAGES, LIABILITIES, COSTS, AND EXPENSES, INCLUDING ATTORNEYS' FEES, RESULTING FROM OR IN ANY WAY RELATED TO ANY DEATH, BODILY INJURY, OR PROPERTY DAMAGE INCURRED AT, CONNECTED WITH, OR AS A RESULT OF PARTICIPATION, WHETHER OR NOT CAUSED BY THE NEGLIGENCE OF THE RELEASED PARTIES.
- 6. Player hereby agrees to indemnify, defend, and hold harmless the Released parties from and against any and all claims, damages, liabilities, costs, and expenses, including attorneys' fees, that the Released Parties may incur in connection with, as a result of or in any way related to Player's participation, excepting such claims caused by the sole negligence of the Released Parties.
- 7. THE PLAYER VOLUNTARILY AND WITH FULL KNOWLEDGE OF THE RISKS, HEREBY ASSUMES FULL AND COMPLETE RESPONSIBILITY FOR, AND RISK OF, DEATH, BODILY INJURY AND/OR PROPERTY DAMAGE RESULTING FROM, CONNECTED WITH, OR IN ANY WAY RELATED TO PLAYER'S PARTICIPATION IN THE CLUB.
- 8. The Player understands that neither medical, not health insurance coverage is supplied by the Club, and that the parents/guardians of the Player are responsible for all medical and/or insurance coverage for the Player.
- 9. The Player gives unto the Club a non-exclusive right, in perpetuity, to use any still or moving image, in photographic, digital, video, or other medium, of the player engaging in participation with the Club for any purpose, commercial or non-commercial, the Club may deem fit, provided that the player is not specifically identified by name or age in said usage. This right is given for the sole consideration and no fee, payment, or any other compensation will be due Player for the use of their image.
- 10. This Agreement shall be deemed a contract made under the laws of the State of Illinois and shall be construed and enforced in accordance with the laws of such state.
- 11. This Agreement shall be binding upon and inure to the benefit of the parties hereto, the Released Parties, their heirs, executors, successors, and assigns.
- 12. In the event that any provision of this Agreement is held invalid, the remaining portions of the Agreement shall remain in full force and effect. The release, waiver, and indemnity provisions contained herein are intended by the parties to be as broad and inclusive as permitted by law and shall be interpreted accordingly.
