From the Coaching Director: To clarify questions regarding coaching certification, here is an update of this year's requirements. All 6U/8U coaches need to be registered with USA hockey and take the 6U/8U module. Level 1 clinics begin at the 10U age group with the required 10U module. There is no requirement clinic for the 6U/8U age group. For Level 4 and Level 5 coaches, although previously promised by USA hockey that achieving this level would not require recertification, the system has been revamped and that is no longer the case. These coaches DO NEED TO RECERTIFY BY 12/31/2025 by obtaining 5 continuing education credits. Thank you.
