#### Important Details:

- SEASON starts on **SUNDAY October 20, 2024**, at TRIO Sportsplex
- Registration spots are limited 1<sup>st</sup> come 1<sup>st</sup> serve (open age group, 18+ men’s league)
- **12 games guaranteed**, 40-minute games (2x 20 mins halves, plus 5 mins break), PLUS Playoffs for those top four (4) teams that qualify.
- Ref fees are **\$15.00/game per team x 12 games** (**league will collect \$180 CASH**) from each team **before first game** and the League will pay the refs directly each week; playoffs are extra if you qualify; your team pays the refs directly.
- **Online Player Registration & Insurance fees \$40/player** (used for player ID, stats, standings etc. on our website)
- All games played at Trio Sportsplex (601 Cityview Blvd, Vaughan, Ontario)
- Teams require a **min. of 9 players**; a **maximum of 15 players dressed per game** and **max. 18 players on the roster sheet**
- The League reserves the right to balance out any and all divisions accordingly along with any and all schedule changes **without teams/player’s approval**

#### Team & Individual Awards:

- Each Division Winner gets Team Cup & Individual Scarves (2 divisions, 2 team winners)
- Each Division TOP GOAL scorer will receive a Cup (2 divisions, 2 winners)
- PLAYOFF WINNERS (2 Divisions, 2 Winning Teams) each get Team Cup & Pizza Party at TRIO Sports Bar

## Payment Plan or Pay in FULL (circle one option)

All teams are required to pay a **minimum \$500 deposit** with their team registration application. Deposit is applied to the overall team registration fee.

### **\*\* COVID 19 closures and Shutdowns \*\***

If we are shut down due to COVID 19 during the regular season and we cannot complete the season – your team will get refunded the percentage of games not played. For example, if we play 30% of the games, and miss 70% of the reminding season – you will get refunded 70% of your team fees. Similar with Ref fees, they will be refunded based on percentage of games not played; but player insurance - **\$40 is Non-Refundable** as we forward those funds directly towards the league insurance.

**Default Rule:** Any team that defaults (no show) or does not attend a VSL game will lose the rights to appear in playoffs. Second defaulted game will result in the team being removed from the league.

### **Registration Agreement:**

The undersigned hereby applies for team franchise in League Season for the above fee and agrees to be bound by the rules and regulations of the league, and furthermore agrees to ensure all fees and fines are paid in full when due and/or suspension without refund. The undersigned acknowledges that the team and its players are required to pay separately game official fees each game, and personal registration fees with local soccer governing bodies. The undersigned is personally responsible for all outstanding team registration fees and fines on or before the dates agreed upon with Versus Soccer League/Versus Sports Management (VSM).

Violation of such rules may result in a team fine and/or suspension. I, the undersigned, as representative of the team and all its players, acknowledge that Versus Soccer League, VSM, Glen Shields FC, Trio Sportsplex, soccer governing bodies, and their agents are not responsible for injuries that may occur in the course of outdoor/indoor soccer games organized by Versus Soccer League, VSM, Trio Sportsplex, Glen Shields FC (GFC). Furthermore, I hereby clear Versus Soccer League, VSM, Trio Sportsplex, Glen Shields FC and its agents against any liability in the event of injury to any of my players, and damage or theft to my team's possessions or personal property that may occur on facility premises and other outdoor premises before, during or after league games. As Team Representative I am taking full responsibility on signing and agreeing on behalf of my players. As Team Representative I am taking full responsibility to notify my players of all the rules and regulations of VSL, VSM, Trio Sportsplex, Glen Shields and all soccer governing bodies to notify them of any changes within the league and make sure that they understand these rules and regulations and any and all team decision will be made by me on behalf of the team which they will know of before any decision is made. I do hereby grant the Versus Soccer League/Versus Sports Management, Trio Sportsplex, Glen Shields FC or contracted photographers/videographers the permission to take photographs or film (web stream) any sanctioned event involving any registered member of the VSL, VSM, GFC & Trio Sportsplex, I also authorize VSL, VSM, GFC & Trio Sportsplex its agents, assigns, successors or transferees without limitation, the full rights to use such photographs/videos for publication in the form taken for the purpose of publicity, illustration, and/or advertising for the VSL, VSM, GFC, Trio Sportsplex related to promotional purposes.
