If you are not a member of USA Hockey (i.e. played on your High School Team) you must register online at <http://www.usahockey.com/> (click on players, then click "online registration"). You will not be able to skate until you are registered and forms are completed.

30-35 players from the District 9 tryouts will be invited to 10 hours of skills training sessions that will take place in Kasson. The fee for these sessions is **\$175.00**. This fee will also be paid online at the above Minnesota Hockey web site address phase 2.

After the skills training sessions, the top 20 players from District 9 plus alternates will be selected from the skills training to participate in a Spring Festival. The fee for the team will be **\$225.00**. This fee will also be paid online at the above Minnesota Hockey web site address. The roster of 20 players plus alternates will have a one practice prior to the festival:

The team will play in the Spring Festival, played in Plymouth Ice Center, on April 23<sup>rd</sup> – April 25<sup>th</sup> 2021. District 9 will be placed in pool play at the festival. 120 Players will be selected to participate in the weeklong camp at St Cloud State University during the Minnesota Hockey Summer Festival held in St Cloud on June 20<sup>th</sup> thru June 24<sup>th</sup>, 2021.

The toughest assignment the coaching staff will face during the entire process is the player evaluation process. Selecting players is not a perfect science and there isn't a perfect method that assures that we will always select the best player. We recognize that and we understand the disappointment of being passed over for another player. The best we can hope for is to give the selection process our fullest attention.
