

## **Game Time Gym Uno Volleyball Club and Uno South Volleyball Club Covid 19 Waiver**

In partnership with Game Time Gym ((GTG, UNO, UNO SOUTH)), Uno Volleyball Club (UNO) and Uno South Volleyball Club (UNO South), we are requesting you to read and sign the document below.

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people.

We collectively have put in place preventative measures to reduce the spread of COVID-19; however, the (GTG, UNO, UNO SOUTH) cannot guarantee that you or your child(ren) will not become infected with COVID-19. Further, attending (GTG, UNO, UNO SOUTH) could increase your risk and your child(ren)'s risk of contracting COVID-19. By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that my child(ren) and I may be exposed to or infected by COVID-19 by attending (GTG, UNO, UNO SOUTH) and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I understand that the risk of becoming exposed to or infected by COVID-19 at (GTG, UNO, UNO SOUTH) may result from the actions, omissions, or negligence of myself and others, including, but not limited to, (GTG, UNO, UNO SOUTH) employees, volunteers, and program participants and their families. I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren) or myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I or my child(ren) may experience or incur in connection with my child(ren)'s attendance at (GTG, UNO, UNO SOUTH) or participation in (GTG, UNO, UNO SOUTH) programming.

On behalf of myself /my child, I certify that I/my child is in normal health and capable of participation in the programs offered by Game Time Gym II. I further certify that my child has medical insurance to cover any injuries sustained as a result of his or her participation in the recreational program. I hereby give my consent and permission for the Game Time Gym II staff to secure emergency medical treatment, including transportation and physician, if required, and I agree to be financially responsible for the costs of such treatment and/or transportation.

On behalf of myself /my child, I agree to hold harmless Game Time Gym II, its officers, employees, servants, agents and hires from any responsibility for any and all personal injuries or death which may result from my/my child's participation in any program offered by Game Time Gym II. I hereby agree to assume any and all of the liability and risks of myself/my child participating in any programs at Game Time Gym II. I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of (GTG, UNO, UNO SOUTH), its employees, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in any (GTG, UNO, UNO SOUTH) program.
