

Bullitt East HS Wall Of Honor Requirements

OVERVIEW

Nomination and Selection Criteria

A person may be nominated in one of the following categories for their contributions made to the Bullitt East High School Athletic Department:

1. Student Alumni
2. Retired Staff
3. Community Member

STUDENT ALUMNI

1. Must have graduated from Bullitt East High School fifteen (15) or more years ago.
2. Have made significant contributions to the community, state, nation or world through good works or charitable beneficence.
3. Must have achieved outstanding success in business, athletics, academics, education, the arts, humanitarian efforts, community service or other endeavors.
4. Must be a role model that current and future generations of Bullitt East High School students can emulate.

RETIRED STAFF

1. Must have been retired or left Bullitt East High School for five or more years prior to nomination and whose efforts have contributed significantly to the district.
2. Must have taught or been an administrator at Bullitt East High School for 15 years or more.
3. Have made significant contributions or achievements that benefited the Bullitt East High School, staff, and/or students.
4. Have exhibited leadership, character and/or service that inspires others.
5. Must be recognized as a positive role model, person of character, one of uncommon dedication who goes beyond the call of duty to assist students, staff and/or parents.
6. The award may be given posthumously.

COMMUNITY MEMBERS

1. Individuals who may or may not have been a graduate of Bullitt East High School, but who have made a significant contribution, which helped make Bullitt East High School a better place.
2. Must be a patron/benefactor /leader that has contributed to Bullitt East High School or the community in an exemplary manner.
3. Must demonstrate leadership, character, service and be a positive role for community members and Bullitt East High School students to emulate.
4. The award may be given posthumously.

SELECTION COMMITTEE

The MWFCA Executive Committee, in conjunction with the Bullitt East Athletic Director / Administration will appoint a committee consisting of seven members, which will determine the procedures of, and elect honorees for induction into the Wall of Honor. The committee will consist of the following members:

- The current MWFCA Executive Director
- The current BEHS Athletic Director, or a BEHS Administrator to be appointed as an alternative.
- A community member who is at least twenty years removed from high school.
- A community member who is less than twenty years removed from high school.
- A current member of the MWFCA Bullitt East Football Alumni Board.
- A community member that is currently serving as a elected Mt Washington city official, or the owner of a local business within the BEHS school district.
- A community member that is currently serving as an elected Mt Washington city official, the owner of a local business within the BEHS school district, or a member of the MWFCA Bullitt East Alumni Board.

SELECTION PROCESS

Any adult, 18 years or older, may make a nomination. The completed nomination form will be made available by April 1st of each year and must be returned to the MWFCA Executive Board no later than June 1st. The nominating individual may elect to include supporting documentation such as records, newspaper clippings, tapes, and letters of support with the nomination form. By June 15th, the Wall of Honor Committee will meet and review the nominations. All votes on the nominees will be conducted by secret ballot. A nominee must receive a minimum of three yeas on the first ballot to qualify for the final selection. On the second ballot each committee member will vote for no more than two candidates. A nominee must receive a majority of votes on the second ballot to be elected into the Wall of Honor. If no candidate/s receives a majority vote, then the candidates with the most votes will be placed on a third ballot and the candidate/s with the least votes will be dropped from the ballot. The process will be repeated until a candidate receives a majority vote. Candidates that were listed on the second ballot, but were not elected into the Wall of Honor, will automatically be reconsidered the following year. The selection committee will determine the number candidates that will be elected to the Wall of Honor each year. The recipients of Wall of Honor will be notified by July 1st. The committee has the ability to select Wall of Honor nominees if to be included in the selection process. The committee reserves the right to remove nominees from consideration if disqualifying events or circumstances arise.
