- **Field Allocations:**

- Schedule does not generally start until later in September due to temperatures being high.
- Ratings Clinics would need to be held at the end of August and beginning of September.
- Both 10/13 and 10/20 would be the day before GSWS starts and the day after it ends respectively. We do have 7 teams participating in GSWS and may decide to take their “bye” week during this time. It is proposed to remove one or both of those dates.
- 16 Game Season which is typical for LVGSL and with a 16-game season it would mean starting the season on 9/8, which is a couple weeks earlier than usual.
- **Open Discussion:**
 - Theo proposes removing 10/20 as it will be the day after the series ends and people may not be in the best shape for playing.
 - Brett is proposing to remove 10/20 so people

don't have to worry about waking up early and can enjoy the closing party

- Tami agrees with Dave's suggestion to remove 10/20.
- Per Dave, 10/13 is also the summer meetings that will be occurring prior to the series starting and all are welcome to attend those meetings and don't need to be a delegate.
- Dave did ask for additional dates, but this is what has been given thus far.
- Field allocation is 9a-3p, we could extend but that does come at an additional cost.
