1. I am 18 years old or older.
2. Playing softball is hazardous and may result in injury.
3. Sliding is dangerous to myself and other players. I will slide at my own risk.
4. Other aspects of softball are dangerous and may result in injury. I will observe all fences, barriers and obstructions prior to the game.
5. Metal spikes are prohibited.
6. I will not fake tag players; I will not crash into other players; I will not throw my bat and/or equipment or conduct myself in a hazardous manner.

FURTHER, IN CONSIDERATION FOR THE RIGHT TO PLAY SOFTBALL AT CITY PARK / LIGHTED FIELD, I AGREE BY SIGNING BELOW THAT:

1. I assume all risks of injury incurred or suffered while on the premises of *Garden City – City Park before*, during and after league play.

I hereby release, hold harmless and agree not to sue the *City of Garden City*, its' officers, all parties involved, servants, associations, employees or sponsors for any claims, loss, damage or injury sustained while on the premises of Garden City Park ball fields. **WHETHER CASES BY ITS NEGLIGENCE OR OTHERWISE**
3. I am aware and understand that copies of the Garden City Parks & Recreation League Rules and Regulations were furnished to this team's manager at the start of the season and I understand and agree that it is my responsibility to read, understand and abide by these rules.
