

# ONTARIO SOCCER YOUTH PLAYER MOVEMENT FORM AGREEMENT

## Between Organizations operating Youth Amateur Teams

**Intent:** To allow organizations operating Youth Amateur Teams to affiliate with another, in order to allow players from one organization to **play up** to the other organization in **league games only**.

**This Agreement is subject to the following Terms:**

1. This Agreement is subject to Ontario Soccer's League Operational Procedure 9.0 Procedure 17.0
2. This Youth Player Movement Form Agreement must be signed by two organizations affiliated with the same District Association under which they agree to "play up" players from a youth team to a higher age or higher classification team of the other organization into a league game.
3. An organization operating youth amateur teams may enter into one Youth Player Movement Form Agreement per season with one other Organization for the purpose of allowing players to "play up". Movement of players can only go one way. (ie. *Players in Club B will "play up" to Club A*)
  - ☐ An organization already entered into a Player Movement Form Agreement can only enter into another Player Movement Form Agreement with a separate organization if there is a limitation with regards to the operation of a team in a specific gender. (ie. *Players in Club B play up to Club A but Club A does not offer both male and female teams, Club B can enter into another Affiliation Agreement with another Club – Club C*)
4. With permission of both organizations in the Player Movement Form Agreement, a youth player may play up in a league game of any youth team with which the organization has a Player Movement Form agreement.
5. The individual players will not register or sign an agreement with the organization they are to "play up" to.
6. Any Youth League may impose limitations on such movement, provided that the limitations are applied consistently.
7. A Youth Recreation player who is also registered as a youth Competitive Player for an organization outside of the Player Movement Form agreement is not permitted to play up to the organization within the Player Movement Form agreement under these provisions.
8. The "Youth Player Movement Form Agreement" must be approved and filed with the following organizations in order to be in effect:
  - a) Ontario Soccer
  - b) the District Association with which the two Organizations are affiliated
  - c) The League in which the "playing up" will be occurring
