

SPRINGFIELD JR THUNDERBIRDS FINANCIAL CONTRACT

My/Our child, _____ has been selected from a tryout process to play for the Springfield JR Thunderbirds full year season. As the Parent(s) and/or Guardian(s) of the above-named player, I/We agree and accept the following terms and financial obligations within the contract.

The terms of this agreement are as follows.

The total tuition is Four Thousand Six Hundred Dollars (\$4,600). I/We the Parent(s) and/or Guardian(s) (hereinafter known as Payer(s)) of the above-named player agree that the full tuition obligation is incurred at the time this contract is signed and tuition payments are not refundable for any reason. I/We, the Payer(s), hereby waive any claims that we may have that the full tuition is not due, or that any part of the full tuition is refundable.

You may pay in full (\$4,600) at the time of commitment using your preferred payment method. Checks are payable to Springfield JR Thunderbirds.

If you do not pay in full in advance, you may enter into an installment plan, the terms of which follow. I/We agree to make tuition payments in accordance with the following schedule: a payment of \$1000 to be paid and delivered along with this signed contract. This \$1000 is non-refundable. This payment reserves your player's spot on this roster. Failure to make this payment in a timely manner could result in the loss of the roster spot. After the initial payment, tuition payments will be made on the first day of each month from May 1 to September 1 in the amount of \$720 per month, for a total tuition amount paid of \$4,600. The commitment payment of \$1000 must be made through the Springfield Junior Thunderbirds online website's payment portal www.juniorthunderbirds.com. Each subsequent \$720 installment will be auto-debited using the same payment method used for the initial commitment payment. Auto-debits will be drawn from your payment method on the first day of each month from May 1 to September 1. You may be responsible banking penalties charged to the Springfield JR Thunderbirds if any scheduled auto-debit fails. You may be charged a \$100 per week late fee if any scheduled auto-debit fails.

All players must be paid in full by September 1. After this date players will not be permitted to participate until full tuition is paid.

I/We the Payer(s) fully understand and agree to accept that all tuition payments or other financial payments made to Springfield JR Thunderbirds season are for the right to practice only. Game ice-time will be determined by the coaching staff based on, but not limited to, traits such as character, talent, discipline, hard work, and attendance at team practices. I/We the Payer(s) understand, and agree, and accept that there may be other expenses and costs associated with my/our son/daughter playing for the Springfield JR Thunderbirds that are not covered by or listed herein on this financial contract, including but not limited to equipment, fuel for your vehicle, meals hotels, tournament expenses, etc. and I/We assume, agree and accept any and all additional costs.

I/We Payer(s) understand, agree and accept that if My/Our Child's association with the Springfield JR Thunderbirds season is temporarily halted by injury or suspension, or is terminated for any reason from the date of execution of this agreement that I/We Payer(s) will remain responsible for continuing to make any outstanding tuition payments and otherwise fulfilling, paying and abiding by the terms of this contract.
