Minutes for UAHA State Board – Monthly Meeting

A Board meeting of UAHA was held on March 4th, 2019, at the Maverik Center. It began at 6:45 pm.

Approval of Minutes

Minute for February were reviewed. No corrections to the minutes were noted. Jason Empey made a
motion to approve December minutes. Motion was seconded by Brian Clements. Motion was approved
unanimously.

Regular Session

- Setting Travel Level tryout schedule Derrick read from Mike Adamek. Discussion regarding
 development over the summer and ADM model. Additional discussion about advantages of combining
 with Tier II tryouts. Further discussion about Steiner closing for the summer making ice harder to find.
 Dewey Reagan made a motion setting Travel Level Tryouts for 14U and above for June, allowing
 Organizations to combine with Tier II Tryouts if applicable; and all other Travel Level Teams to hold
 tryouts in August or later. Doug Anne 2nd the motion. Majority Approved. Jason Empy Opposed.
- Proposal to amend the Policies and Procedures to requires High School to have their playoffs completed the last Sunday in February. A brief discussion laying out some of the difficulties that arose this year between the High School Playoffs and the Tier II Tournament. Each group has players who play on both teams making impossible for there to be overlapping scheduled games. It was explained that Tier does not know how many teams they have and how many games will be required until October. High School knows in July. Some of the ideas presented, have Tier do their playoffs right after MLK, consider having HS D2 do their games after Tier. No motion made. Agreed to continue discussion at the April meeting.
- Review Tier Team Applications
 - Tier I Applications
 - WCR 18U, 16U, 15, 14U
 - WCR Representatives indicated that if the talent level was not Tier I level, they would drop age groups
 - Dewey Reagan made a motion to approve all Tier I applications, with the condition that all outstanding fees to UAHA be paid. Jason Empy 2nd the motion. Motion passed unanimously.
 - Tier II (Youth)
 - There was discussion about the applications received from DCYHA and from the Eagles. Eagles submitted an application that only had Travel Level Teams. DCYHA submitted an application with Tier II through D1/D2 level teams. It was noted that Eagle are under the DCYHA organization. It was also noted that Eagles/DCYHA may need to be reminded about the UAHA policy that required them to go to a single identifying team/logo when "Jersey" changes are made.

- Dewey Reagan made a motion to approve all Tier II applications, with the condition that all outstanding fees to UAHA be paid. Jason Empy 2nd the motion. Motion passed unanimously.
- Tier II Girls Applications
 - Utah Lady Grizzlies 19U & 14U
 - Possible change request back to UAHA if ages of committed players allows for different age groups
 - Dewey Reagan made a motion to approve all Tier II Girls applications, with the condition that all outstanding fees to UAHA be paid. Doug Anne 2nd the motion. Motion passed unanimously.
- Review Travel Team Applications Patty Bigelow was absent and no meeting of the Youth Organizations
 was held so the discussion was postponed to April.
- High School Hockey Proposal Presented by Pam Pala on behalf of Matt Holloway and Shannon Woodhall, UHSH proposed the state board pay the tournament entrance fee for both Viewmont and the SL Stars for Nationals this season. The fee to enter is new this year, In the past the state board has paid these fees for Tier teams. The fee is \$1500 per team, so a total of \$3000. It should also be noted that UHSH has already allotted and given Viewmont and SL Stars \$10,000 each, totaling \$20,000, from the league for HS Nationals. See additional information attached. Discussion centered around UAHA not having paid for Nationals fees for several years, and they just denied an application by a Women's "B" team. Jason Empy made a motion to deny the request. Brian Clements 2nd the motion. Approved in the majority. Jill Day opposed.
- Review Notice of Election UAHA Annual Election is held at the end of April. See attached draft Notice.
 High School VP, and Girls/Women positions were just appointed in 2018, however per the UAHA Bylaws,
 Article 11--Vacancies and Removal, Section 1. "Vacancies on the Board of Directors shall be filled by
 appointment of the Board, by a majority vote of the remaining members of the Board present at the
 meeting called to fill the vacancies. The appointed replacement shall serve until an election for the
 position can be held". (Derrick Radke)

 - o Anaheim Lady Ducks are coming to SLC for a Girls Camp in June
 - Discussed Girls St. Lewis Showcase. There is room for at least 4 players

 - o Attended USAH Clinic on Body Checking in Colorado Springs.
 - Reviewed discussion with Joe Bonnett (USA Hockey regional ADM Manager) last weekend in regard to a body contact/checking clinic as discussed in last month's board meeting. His recommendation is to setup a Checking and Body Contact Clinic for all interested coaches in early fall that can be supported by USA hockey. His reasoning for waiting is so that it will be fresh in the minds of the coaches entering the next season, and any new rules adopted this summer can be introduced. I would like to work with Wayne to set this up and make it available to the coaching staff.

Also, he has concerns about misinformation that has been circulating in regard to removing Body checking from 14U in his neck of the woods and would like to try to get ahead of it in Utah if he can. He would like to setup a call-in meeting for Coaching Directors and Organizational Management of effected organizations in Utah in the next 6-8 weeks to discuss the direction USA Hockey is taking in regard to Checking at all age groups.
