



## FAQ

**Question: Is there a certain time limit to sign my child up for camp?**

**Answer:** YES. We are registering children for a full 6 weeks or two 3 week increments. Please call Karyn Taylor for an appointment @ 201-330-2077/ 201-330-2000 ext. 3203. Applications(in person) will be accepted starting on June 14th and go through June 30th. Please see Karyn Taylor at the Secaucus Recreation board officer 20 Centre or call.

**Question: What is the counselor to camper ratio?**

**Answer:** Approximately 3:1

**Question: How are the children divided?**

**Answer:** According to grade

**Question: Will campers have the same counselors for the duration of the summer?**

**Answer:** We try to keep a structured schedule with campers and counselors. Switches may be made throughout the summer.

**Question: Do you have guidelines regarding the use of electronics (video games, cell phones, etc.)**

Answer: We try to stay away from electronic use as this is a camp filled with physical activities, arts & crafts, Science etc. We ask that children leave cell phones in their bags.

**Question: Does each camper receive only 1 shirt?**

Answer: yes, unless we have extra and may be purchased at a later time.

**Question: Are you allowed to administer medication to my child?**

Answer: NO we are not allowed to administer any medication.

**Question: Are members of staff CPR/AED/FIRST AID Certified?**

Answer: Yes, and certified to administer an EPI pen if needed.

**Question: Are all campers required to swim?**

Answer: NO

**Question: Where does the pee wee camp go at the town pool?**

Answer: The fenced in kiddie Pool

**Question: Do I need to apply Sunscreen?**

Answer: Yes. Everyday.

**Question: If my child has special needs is there someone to speak to?**

Answer: Yes. We have 2 Special Education coordinators for camp and a Parent Liaison coordinator **Abby Gonzalez 201-870-7975.**

**Question: In case of an emergency who do I contact. Coordinators' phone numbers are on the parent manual. If you cannot reach them, please call 330-2078.**

**Question: If I pick up my child late from camp is there a fee?**

**Answer: YES \$25 which is the fee for extended camp.**

**Question: Can I allow my child to walk to camp and leave camp on their own?**

**Yes, Senior campers only with a written note.**

**Question: Can my child be terminated from camp**

**Answer: Yes, at the discretion of the Director, no refund.**

**Question: Will there be daily updates on the camp schedule**

**Answer: Yes, If trips change.**

**Question: Is there a different fee if a family qualifies for low income?**

**Answer: Yes, documentation will be needed. Lisa Snedeker 201-617-5917**

**Question: Does my child need to wear a mask? Parents are required to wear masks. Answer: Yes**
