

# **JERSEY SWEEPSTAKES RULES**

## **NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN.**

The “Jersey Sweepstakes” (the “Sweepstakes”) is sponsored by United Soccer League, LLC (“Sponsor”) and governed by these official rules (“Official Rules”). By participating in the Sweepstakes, each entrant agrees to abide by these Official Rules, including all eligibility requirements, and understands that the results of the Sweepstakes, as determined by Sponsor and its agents, are final in all respects. The Sweepstakes is subject to all federal, state and local laws and regulations and is void where prohibited by law.

### **ELIGIBILITY**

The Sweepstakes is open to legal residents of their continental United States where not prohibited by law, who are eighteen (18) years of age or older at the time of entry, and who have access to a compatible mobile device and a valid e-mail account prior to the beginning of the Sweepstakes Period (as defined below). Sponsor has the right to verify the eligibility of each entrant.

### **SWEEPSTAKES PERIOD**

The “Sweepstakes Period” is the time during which submissions may be received. It begins at 12:00 p.m. EST on March 5, 2020 or at such later time on March 5, 2020 when these rules are posted. It ends at 12:00 p.m. EST on March 12, 2020. Sponsor reserves the right to extend or shorten the Sweepstakes Period in its sole discretion.

### **HOW TO ENTER**

During the Sweepstakes Period, you can enter the Sweepstakes by providing a valid e-mail address during the process of registering for an account within the USL Mobile Application (the “App”) and indicating your favorite team or teams (the “Sweepstakes Entry”). Entrants may pick as many favorite teams as they wish.

### **WINNER SELECTION**

The winners (each, a “Winner”) will be chosen by random drawing of all eligible Sweepstakes Entries for the favorite team indicated, except that no Winner will receive more than one (1) prize. Sponsor will select up to 47 Winners, based on Prize availability. Sponsor’s determination of the number of Winners is final and in Sponsor’s sole discretion, and Sponsor makes no guarantee that any jersey will be available for your indicated team.

The Winner will be notified on Monday, March 12 or Tuesday, March 13. Notification and instructions for collecting the prize will be sent to the e-mail address you supplied in the App registration process. Each Entrant is responsible for monitoring his/her e-mail account for prize notification and receipt or other communications related to this Sweepstakes. If a potential prize winner cannot be reached by Sponsor within three (3) days using the contact information provided at the time of entry, or if the prize is returned as undeliverable, that potential prize winner shall forfeit the prize. Upon the request of the Sponsor, the potential winner may be required to return an Affidavit of Eligibility, Release and Prize Acceptance Form, and IRS W-9 form. If a potential winner fails to comply with these official rules, that

potential winner will be disqualified.

**PRIZE:**

One (1) jersey with an approximate retail value of one hundred and twenty dollars (\$120). If for whatever reason, Sponsor is unable to secure such tickets, Sponsor may determine an alternative prize in its sole discretion.
