

“PICK ‘EM TICKET GIVEAWAY” CONTEST RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN.

The “Pick ‘Em Ticket Giveaway” (the “Contest”) is a weekly contest sponsored by United Soccer League, LLC (“Sponsor”) and governed by these official rules (“Official Rules”). By participating in the Contest, each entrant agrees to abide by these Official Rules, including all eligibility requirements, and understands that the results of the Contest, as determined by Sponsor and its agents, are final in all respects. The Contest is subject to all federal, state and local laws and regulations and is void where prohibited by law.

ELIGIBILITY

The Contest is open to legal residents of their continental United States where not prohibited by law, who are **eighteen (18) years of age** or older at the time of entry, and who have access to a compatible mobile device and a valid e-mail account prior to the beginning of the Contest Period. Sponsor has the right to verify the eligibility of each entrant.

CONTEST PERIOD

The Contest Period is the time during which submissions may be received. It begins each Tuesday during the regular season at such time when Sponsor posts the weekly Pick ‘Em competition within the USL mobile application (the “App”). It ends each Friday during the regular season at 5:00 PM EST. Sponsor reserves the right to extend or shorten any or all Contest Periods in its sole discretion.

HOW TO ENTER

You can enter the Contest by registering for an account within the App and submitting responses to all five (5) questions related to the Pick ‘Em Ticket Giveaway (the “Contest Entry”). The questions your Contest Entry must answer include your guess of the outcome of four upcoming games (the “Featured Games of the Week”). and a guess as to which Featured Game of the Week will produce the most combined goals scored. The Featured Games of the Week and statistic will be selected by Sponsor Staff.

WINNER SELECTION

The winner will be chosen by the following process. At the outset, ineligible applicants will be disqualified. If no applicants select the correct outcomes, the winner will be decided by a random draw of eligible applicants. If multiple applicants select the correct outcomes, the winner will be the applicant who correctly chose the game that would be decided by the largest margin. If multiple applicants correctly choose the match decided by the largest margin, the winner will be decided by a random draw.

The winner will be notified on Monday of the week following submission of the Contest Entry, on or about 12:00 PM EST, each week during the regular season. Notification and instructions for collecting the prize will be sent to the e-mail address you supplied in the App registration process. Each entrant is responsible for monitoring his/her e-mail account for prize notification and receipt or other communications related to this Contest. If a potential prize winner cannot be reached by Sponsor within three (3) days using the contact information provided at the time of entry, or if the prize is returned as undeliverable, that potential prize winner shall forfeit the prize. Upon the request of the Sponsor, the potential winner may be required to return an Affidavit of Eligibility, Release and Prize Acceptance Form, and IRS W-9 form. If a potential winner fails to comply with these official rules, that potential winner will be disqualified.

PRIZE:

Four (4) tickets to one of the next three (3) home game of the winner's favorite United Soccer League team (as indicated during the App registration process and/or through e-mail confirmation), with no guarantees as to the location of the tickets. For clarity, the next home game may not be the following week, depending on scheduling. If the winner's favorite United Soccer League team has no upcoming home game, or if for whatever reason, Sponsor is unable to secure such tickets, Sponsor may determine an alternative prize in its sole discretion.

Terms and conditions may apply. Incidental expenses and all other costs and expenses which are not specifically listed as part of a prize in these Official Rules and which may be associated with the award, acceptance, receipt and use of all or any portion of the awarded prize are solely the responsibility of the respective prize winner. ALL FEDERAL, STATE AND LOCAL TAXES ASSOCIATED WITH THE RECEIPT OR USE OF ANY PRIZE IS SOLELY THE RESPONSIBILITY OF THE WINNER.

ADDITIONAL LIMITATIONS

Prize is non-transferable. No substitution or cash equivalent of prizes is permitted. Sponsor and its respective parent, affiliate and subsidiary companies, agents, and representatives are not responsible for any typographical or other errors in the offer or administration of the Contest, including, but not limited to, errors in any printing or posting of these Official Rules, the selection and announcement of any winner, or the distribution of any prize. Any attempt to damage the content or operation of this Contest is unlawful and subject to possible legal action by Sponsor. Sponsor reserves the right to terminate, suspend or amend the Contest, without notice, and for any reason, including, without limitation, if Sponsor determines that the Contest cannot be conducted as planned or should a virus, bug, tampering or unauthorized intervention, technical failure or other cause beyond Sponsor's control corrupt the administration, security, fairness, integrity or proper play of the Contest. In the event any tampering or unauthorized intervention may have occurred, Sponsor reserves the right to void suspect entries at issue. Sponsor and its respective parent, affiliate and subsidiary companies, agents, and representatives, and any telephone network or service providers, are not responsible for incorrect or inaccurate transcription of entry information, or for any human error, technical malfunction, lost or delayed data transmission, omission, interruption, deletion, line failure or malfunction of any telephone network, computer equipment or software, the inability to access any website, App or online service or any other error, human or otherwise.
