

**NORTHFIELD VOLLEYBALL CLUB
VOLUNTARY WAIVER OF LIABILITY AGREEMENT**

THIS DOCUMENT AFFECTS YOUR LEGAL RIGHTS. PLEASE READ CAREFULLY BEFORE SIGNING

The below-named Participant wishes to participate in NVC tryouts, practices, games, and tournaments (the "Activity") through Northfield Volleyball Club ("NVC"). Participant and/or Participant's parent, custodian, or legal guardian (on behalf of him/herself and Participant) understands, acknowledges, and affirms as follows:

- (1) Participant's participation is strictly voluntary. No one is forcing or requiring Participant to participate.
- (2) The Activity Participant is about to voluntarily engage in may be dangerous and may involve certain risks, including but not limited to bodily injury, personal injury, sickness, disease, COVID-19, death, and property loss or damage to Participant or others. By executing this Voluntary Waiver of Liability Agreement, Participant and (if applicable) Participant's parent, custodian, or legal guardian (on behalf of him/herself and Participant) assumes all such risks, known or unknown, anticipated or unanticipated.
- (3) In consideration for being allowed to participate in this Activity, Participant and (if applicable) Participant's parent, custodian, or legal guardian (on behalf of him/herself and Participant) hereby agree to release NVC, its insurer, and anyone working on behalf of NVC from any claims or actions arising out of or in any way related to the above-described Activity. Participant and (if applicable) Participant's parent, custodian, or legal guardian (on behalf of him/herself and Participant) waive any right to make claims or bring lawsuits against the NVC or anyone working on behalf of NVC, for any injuries or damages arising out of or in any way related to the above-described Activity.
- (4) In consideration for being allowed to participate in this Activity, Participant and (if applicable) Participant's parent, custodian, or legal guardian (on behalf of him/herself and Participant) agree to release, defend, indemnify, and hold harmless NVC, officials, employees, insurers, agents, contractors, representatives, and servants, from and against all liabilities, claims, causes of action, demands, losses, damages, judgments, and other obligations (including attorneys' fees and costs), including those arising from any third party claims, on account of injury, loss or damage which arise out of or are in any way related to Participant's participation in the Activity.
- (5) This agreement extends to all acts, omissions, negligence, or other fault of NVC, officials, agents, contractors, servants, or employees, and that this Agreement is intended to be as broad and inclusive as is permitted by law.
- (6) This release and waiver does not apply to any injuries or damages that are the result of any willful, wanton, or intentional misconduct by NVC.
- (7) Participant and (if applicable) Participant's parent, custodian, or legal guardian (on behalf of him/herself and Participant) understand that entering into and signing this agreement affects Participant's rights and results in the giving up or waiving certain legal rights; and Participant and (if applicable) Participant's parent, custodian, or legal guardian accept this and sign this agreement of his/her/their own free will.
- (8) The terms of this agreement shall be binding upon Participant and Participant's parents, conservators, representatives, agents, assigns, or legal guardians if Participant is alive; and Participant's heirs, representatives, executors, and assigns if Participant is deceased.
- (9) I attest that:
 - I am not experiencing any symptom of illness such as cough, shortness of breath or difficulty breathing, fever, chills, repeated shaking with chills, muscle pain, headache, sore throat, or new loss of taste or smell.
 - I have not traveled internationally within the last 14 days.
 - I have not traveled to a highly impacted area within the United States of America in the last 14 days.
 - I do not believe I have been exposed to someone with a suspected and /or confirmed case of the Coronavirus/COVID-19.
 - I have not been diagnosed with Covid-19 and not yet cleared as non-contagious by state or local public health authorities.
 - I am following all CDC recommended guidelines as much as possible and limiting my exposure to COVID-19.
- (10) I understand that I may not attend any NVC event if any of the items in (9) are true.
- (11) I understand that an inherent risk of exposure to Covid-19 exists in any public place where people are present. By participating in NVC events, I voluntarily assume all risks related to exposure to Covid-19.
- (12) I acknowledge the following responsibilities:
 - I am responsible for monitoring health and symptoms before all NVC events. If I have a fever over 100.4 degrees Fahrenheit, I will notify the head coach and stay home until fever free without any fever reducing medicine.
 - I must not participate in NVC events if I have any of the following symptoms: cough, shortness of breath, or sore throat. I will not participate until I am symptom free.
 - I must not participate in NVC events if I or anyone in my household tests positive for Covid-19 or has been told to self-quarantine.
 - I must notify the head coach immediately if I test positive for Covid-19. I understand that NVC staff will notify my team that a team member has tested positive without identifying the individual.
 - I must wear a face covering when upon arrival and departure to any NVC activity. I must abide by social distancing protocols explained by NVC staff and coaches. I will wear a face covering when entering and exiting the court. I will wash/sanitize my hands when I arrive and before I leave any NVC event. I must provide my own water bottle for all NVC events.

The undersigned signature indicates that the undersigned has read this entire agreement, understands it completely, acknowledges that it cannot be modified or changed in any way by oral representation, and agrees to be bound by its terms.

NORTHFIELD VOLLEYBALL CLUB COVID-19 PLAN

- An inherent risk of exposure to Covid-19 exists in any public place where people are present.
- Covid-19 is an extremely contagious disease that can lead to severe illness or death.
- By participating in Northfield Volleyball Club (“NVC”) activities, you voluntarily assume all risks related to exposure to Covid-19.

NVC has implemented the following health and safety measures for the safety of all players and coaches. Players must follow all instructions provided by NVC staff while participating in NVC activities, including the following:

- Maintain 6’ distance wherever possible.
- Parents may not enter practice facilities. Players shall arrive no more than 10 minutes prior to the scheduled practice start time. Facilities will be locked and doors cannot be propped open.
- Players and coaches will wear face covering and use hand sanitizer when entering any facility for practice or games.
- Coaches must wear face covering at all times.
- During games, players must wear face covering when entering and exiting the court, but not during play.
- Players will wear face covering during team huddles and during practice as much as possible.
- Players cannot use drinking fountains and must provide a water bottle for all NVC events.
- Each team will use its own set of balls for all practices, which will be sanitized at the end of each practice.
- Only one team will practice on each court during assigned practice times; teams will not share courts. Teams will be limited to 12 or less players.
- Players will store their bags and water bottles in the gym during practice, 6 feet from others.

NVC players and coaches understand that participation in NVC events requires each participant to certify the following:

- I am not experiencing any symptom of illness such as cough, shortness of breath or difficulty breathing, fever, chills, repeated shaking with chills, muscle pain, headache, sore throat, or new loss of taste or smell.
- I have not traveled internationally within the last 14 days.
- I have not traveled to a highly impacted area within the United States of America in the last 14 days.
- I do not believe I have been exposed to someone with a suspected and /or confirmed case of the Coronavirus/COVID-19.
- I have not been diagnosed with Covid-19 and not yet cleared as non-contagious by state or local public health authorities.
- I am following all CDC recommended guidelines as much as possible and limiting my exposure to COVID-19.

All players and coaches must also comply with the following responsibilities:

- Each participant is responsible for monitoring health and symptoms before all NVC events. If any participant has a fever over 100.4 degrees Fahrenheit, the participant will notify the head coach and stay home until fever free without any fever reducing medicine.
- A participant must not participate in NVC events if experiencing any of the following symptoms: cough, shortness of breath, or sore throat. Participants cannot return to NVC events until symptom free.
- Participants must not participate in NVC events if they or anyone in their household tests positive for Covid-19 or has been told to self-quarantine.
- Participants must notify the head coach immediately if they test positive for Covid-19. NVC staff will notify the team that a team member has tested positive without identifying the individual.
