Organizations, associations, groups, or individuals making funding requests to the LCRA are expected to submit requests to other funding organizations in an effort to lessen the commitment of the LCRA.

Funding request that provide benefits to a greater number of Little Canada youth residents will be given priority consideration.

When requesting funds, a representative of the organization, association, group, or the individual, may be required to attend the LCRA membership meeting to present information and answer any questions the membership may have. The LCRA meets in the evening on the second Tuesday of every month at the Old Fire Hall 440 Little Canada Road, Little Canada, MN 55117.

The application must be submitted prior to the first day of the month to be included on that month's meeting agenda.
