 - i. 245 players were reviewed, 6,860 questions
 - ii. 23 appeals for questions
 - 1. 6 were clerical errors (stood and upheld)
 - 2. 2 appeals, coach sided with appeal – didn't change division threshold
 - 3. 15 appeals went to vote from coaches.
 - a. 8 upheld, 7 denied
 - 4. Final spread sheet will be sent out once women is complete
 - 5. Most people just adjusted up or down a point.

 - i. Don't have anything from city yet for Doc Romeo

 - 1. City waiting for paperwork before being official.
 - iii. County (Sunset)
 - 1. 5 dates granted at four plex
 - a. March 6, 27, April 3, 14 (Easter), May 1
 - 2. 4 dates granted for warm springs corner
 - a. March 13, April 3, May 8, 15
 - iv. Decision doesn't have to be tonight but by next meeting we would have to already have to decide fields for the spring.
 - v. If we don't use Doc Romeo at all for spring, we lose seniority for 2 years.
 - vi. Dave: Mix between both would be nice but up to coaches
 - vii. Za-Za: could we do clinics at one field and league play at the others?
 - 1. No because clinics would be before allocations.
 - viii. Nicky: When we do have the dates for the four plex can we schedule more games since we have more fields? – Yes, more games going on at one time, more games can be scheduled.
 - ix. Randy Register: Have we tried getting other fields like desert breeze? – Attempted to but did not get them. Arroyo only works with the city of Henderson, not private leagues.
 - 1. Maybe see about working with city of North Las Vegas about Cheyenne fields?
