

SPONSORSHIP AGREEMENT
NORTHERN LIGHTS FIGURE SKATING CLUB

This is an agreement between _____ and the Northern Lights Figure Skating Club (NLFSC).

The above sponsor does hereby agree to the terms of the contract, in which the sponsor display will be (size & location described below) posted within the arena of the East Grand Forks VFW Ice arena, in East Grand Forks, MN.

TYPES OF ADVERTISING

- A. Approx. (3X6) ad board in view of stands. (locker room side) Cost \$450/YR
- B. Approx. (3x6) ad board behind spectator stands (concession side) \$400/YR
- C. Approx. (4x8) ad board on outside wall of rink (stand view, concession side) \$450/YR
- D. Approx. (1x3) ad board on end walls \$200/YR
- E. Approx. (3x8) ad board players box (limited quantity) only 2 available \$700/YR
- F. In-Ice Ad limited quantities. \$800 (Approx. 25 SQ. FT DISPLAY) \$20.00 per s/f additional. (ONE YEAR AGREEMENT ONLY) Order by September 1st.

All sponsorships will consist of a five (5) year agreement between the NLFSC and the sponsor, with the exception of "In-Ice" advertisements. The cost of the print and board will be included in the cost of the five-year agreement (but not exceeding \$150.00 for the 3x6, 3x8 & 4x8 display or \$75 for 1x3 display) for the board and graphics depending on the sponsor's display request.

All yearly payments are due by October 1st of each year. However, if the five-year contract is paid in full a 10% discount will be offered.

At the end of the five-year agreement, the sponsor will be contacted regarding renewal of their sponsorship. Only a five-year renewal will be offered. If any change in the graphic display is requested the sponsor may change display at their own expense.
