BY EXECUTING THIS AGREEMENT, YOU WILL WAIVE CERTAIN LEGAL RIGHTS, INCLUDING THE RIGHT TO SUE. PLEASE READ CAREFULLY.

In consideration of being allowed to use the above-named facility on the date(s) indicated, the undersigned hereby releases and waives all claims for liability against the North Shore Girls Soccer Club, and all their employees, officers, agents, board members, volunteers and any and all individuals and organizations assisting, arising or in any way predicated upon acts or omissions, in connection with the undersigned group or organization's use of the above-described facilities or property.

The undersigned agrees to indemnify and hold harmless the North Shore Girls Soccer Club, their employees, officers, agents, board members, volunteers, and any and all individuals and organizations assisting, from any and all liability arising out of, or in any manner predicated upon, loss or damage to property, injury or death to members of the undersigned group or organization, which injury may occur in connection with the use of the NSGIF. This indemnity applies whether or not such injury, loss, or damage arises, in whole or in part, from the negligence of the North Shore Girls Soccer Club, its employees, officers, agents, board members, volunteers and any and all individuals and organizations assisting the Club in its operations.

The undersigned further states that they are of lawful age and legally competent and empowered to sign this waiver and release on their own behalf and that this waiver and release is freely given.

Safety – In entering into this Agreement, I am not relying on any oral, visual or written representations of statements made by the Releasees with respect to the safety of soccer/athletic programs other than what is set forth in this agreement.



Insurance – I am aware that NSGSC carries insurance and should I become injured or cause personal injury or property damage to any third party while participating in programs at the NSGIF, I may or may not be entitled to insurance coverage depending on the terms and conditions of NSGSC's insurance policy.

Jurisdiction – This agreement and any rights, duties and obligations as between the parties to this agreement shall be governed by and interpreted solely in accordance with the laws of the Province of British Columbia, and I agree to attorn solely to the jurisdiction of the Courts of the Province of British Columbia. Any litigation involving the parties to this Agreement shall be brought solely within the Province of British Columbia and shall be within the exclusive jurisdiction of the Courts of the Province of British Columbia.
