



## Important Instructions for State Tournament Qualifiers

Congratulations on qualifying for a 2021 Minnesota Hockey State Tournament! To help your team continue its success, we have organized this packet to ensure you have all the information you need to make your trip to State an unforgettable experience!

### Rosters & Logos

Minnesota Hockey's commemorative State Tournament program will include every participating team's roster and logo. **Please email your team's roster and logo to Minnesota Hockey at [tournaments@minnesotahockey.org](mailto:tournaments@minnesotahockey.org) and the host tournament coordinator (see 2<sup>nd</sup> page) no later than Noon on Monday, March 22nd, 2021.**

### Lodging & Banquets

Your State Tournament host should have a block of rooms set aside for you at a local hotel. We recommend contacting the tournament coordinator as soon as you qualify to find out which hotel your block is set at.

### Tournament & Spectator Fees

Each team participating in a State Tournament entry fee of \$400.00, payable to the host association or district. Payment must be received by the first game of tournament.

State Tournaments will be charging the spectator fees listed below in advance, per MN Dept. of Health requirements. Contact the tournament host for information on how to pre-purchase entry passes.

\$20.00 - Tournament Pass

\$10.00 - Daily Pass

\$10.00 - Senior and Student Tournament Pass

\$8.00 - Senior and Student Daily Pass

Free - 10 and under

Free - Veterans and Active duty in Uniform

*Note: Tournament passes from other State Tournament sites are not transferable.*
